Winston Gold has also acquired five additional claims in the region to form part of the Property, in consideration of the payment of 1,500,000 common shares in the capital of the Company to the Lessor. The disclosure should be sufficiently complete to enable a reader to appreciate the significance of the acquisition without reference to any other material: On May 18, 2016 Winston Gold Mining Corp., it's wholly owned subsidiary Winston Gold Mining USA Corporation and Winston Realty LLC (The "Lessor") amended the mining lease agreement entered into on July 15, 2014 (the "Lease") over minerals claims constituting the Winston District Gold Project in Broadwater County, Montana (the "Property"). The term of the lease has been extended to July 15, 2034. In consideration of US \$40,000 and advanced royalty payments of US \$5,000 monthly payable to the Lessor, the term of the lease has been extended until July 15, 2034. Winston Gold has also acquired five additional claims in the region to form part of the Property, in consideration of the payment of 1,500,000 common shares in the capital of the Company to the Lessor. Additionally, Winston Gold acquired an option to purchase all subsurface rights made the subject of the Lease as well as 100 acres of land held by the Lessor for a purchase price of US \$2,000,000, exclusive of applicable sales and transfer taxes or other registration fees and charges. The Lessor has retained a right to buy back all rights and terminate the lease of US \$1 in the circumstances were there is a cessation of all mining, mineral exploration, and minerals processing activities for a consecutive period of five years.
