The Issuer entered into a binding asset purchase agreement with CMAX, a related party of the Issuer, on August 21, 2020 to purchase certain cannabis processing equipment and leasehold improvements (the "CMAX Assets") located at the Issuer's facility at 223 Riviera Drive, Markham, Ontario. The purchase price of the CMAX Assets was based upon third party valuations of the CMAX Assets ordered by CMAX. The purchase price of the assets of \$1,018,000 was satisfied through the issuance of 1,996,078 common shares of the Issuer at a deemed price of \$0.51 per common share. 200,000 Common Shares were issued on August 21, 2020 as a deposit towards the purchase price.

The Issuer entered into a binding asset purchase agreement with Pharma to purchase cannabis processing equipment owned by Pharma on August 21, 2020. The purchase price of the assets of \$300,000 was satisfied through the issuance of 588,235 common shares of the Issuer at a deemed price of \$0.51 per common share. Joshi Laxminarayan, Chief Scientific Officer of the Issuer, is the sole officer, director and shareholder of Pharma.

## Appendix A

### PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To determine whether an individual is suitable to be associated with a Listed Issuer;

- To conduct enforcement proceedings;
