The Issuer holds several mineral exploration properties located in northern Nevada, the primary of which is the Hot Springs Peak property (HSP). A 43-101 technical report in connection with the Hot Springs Peak property is available on SEDAR. The Issuer also controls a land position in the Buena Vista Valley named the Star Point. The Issuer reports the results of exploration activities on both project areas as they become available.

The Issuer also has an option agreement with Canarc Resource Corp., pursuant to which the Issuer holds an option to acquire 100% of the Fondaway Canyon and Dixie Comstock properties. These are advanced stage projects located in Churchill County, Nevada.

The Issuer renegotiated the terms of its mining lease agreement for the "Star" group of 199 unpatented lode mining claims situated in Pershing County, Nevada (refer to Issuer news release dated July 28, 2020 for further details).

2. Provide a general overview and discussion of the activities of management.

The Issuer is preparing to complete a new technical report on Fondaway Canyon and is conducting a comprehensive synthesis and geological reinterpretation of the substantial volume of data received (refer to Issuer news release dated March 30, 2020 for further details). The efforts to date have increased the Issuer's understanding of the mineralization at Fondaway Canyon. A news release issued on June 29, 2020 provides details on the underground channel samples collected by a previous operator at Fondaway Canyon and states that the Issuer is planning and has provided a deposit to ensure rig availability for the 2020 drill program at Fondaway Canyon.
