The Company's main activities have included advancing its three core programs, including its N,N-dimethyltryptamine ("DMT") stroke research program, its idiopathic pulmonary fibrosis ("IPF")/chronic cough program with Ifenprodil and its chronic kidney disease ("CKD") research program with Repirinast with the Company announcing, on April 26, 2022, that Repirinast reduced fibrosis by 56% with statistical significance, in a preclinical study investigating non-alcoholic steatohepatitis ("NASH") in the STAMTM mouse model from SMC Laboratories (Japan).

Additionally, the Company continues to advance its oncology research program.

The Company had previously completed enrollment in its Phase 2 Ifenprodil IPF and chronic cough study, with the final patient completing the treatment period for the study on May 5, 2022 and the Company expects topline data to be available in July 2022.

Preclinical activities continue on the Company's DMT stroke research program as the Company advances towards a Phase 1 clinical trial expected to begin calendar Q3 2022

The Company recently began its CKD research program and announced that Repirinast reduced fibrosis by 56% with statistical significance, in a preclinical study investigating NASH in the STAMTM mouse model from SMC Laboratories (Japan).
