Tartisan is a company incorporated under the laws of Ontario. Tartisan is a Canadian exploration and development company focused on mineral exploration and development of precious and base metals properties in Canada and Peru.

On February 12, 2021, Tartisan purchased 224,000 Common Shares, at \$0.10 per Common Share for an aggregate purchase price of C\$22,400. (the “**Transaction**”).

Tartisan owned by direct ownership 9,489,252 common shares (“Common Shares”) of the Peruvian Metals Corp. and 1,000,000 warrants (“Warrants”) to purchase one additional

Common Share per Warrant exercisable at a price of \$0.10 prior to expiry on October 5, 2022. The acquisition of Common Shares represents a increase in Tartisan's holdings from 9.999% to 10.23% on a non-diluted basis of the issued and outstanding Common Shares.

Tartisan acquiring of ownership of an aggregate of 224,000 Common Shares increased its holdings which had required the filing of this report.
