Tartisan is a company incorporated under the laws of Ontario. Tartisan is a Canadian exploration and development company focused on mineral exploration and development of precious and base metals properties in Canada and Peru.

2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

Between March 15, 2021 and March 25, 2021, the Acquiror acquired directly a total of 3,153,500 common shares representing 3.33 % of the issued common shares of Peruvian. (the “**Transaction**”).

Tartisan owned by direct ownership 11,630,752 common shares ("Common Shares") of the Peruvian Metals Corp. and 1,000,000 warrants ("Warrants") to purchase one additional Common Share per Warrant exercisable at a price of \$0.10 prior to expiry on October 5, 2022. The acquisition of Common Shares represents an increase in Tartisan's holdings from 12.256% to 15.58% on a non-diluted basis of the issued and outstanding Common Shares.

Prior to the Transaction, Tartisan held 11,630,752 Common Shares, representing approximately 12.226% of the Common Shares. As a result of the Transaction, Tartisan now owns 14,784,252 representing 15.58% of the outstanding Common Shares on a non-diluted basis.
