Management was engaged in the evaluation of potential projects for acquisition in Suriname and is reviewing other property acquisitions for gold

and other metals in other jurisdictions including its previously announced interest in two claim blocks with a total area of 980 hectares (the "Caribou Project") in the area of the Seymour and Crescent Lake pegmatite groups in northern Ontario. The properties have potential for Lithium-Cesium-Tantalum pegmatites.

In a press release dated March 11,2024, the Issuer announced that it has arranged to borrow money from certain shareholders including \$5,000 from President and CEO Jon North, for a total, in aggregate, of \$47,500 which funds will be used to settle invoices with certain contractors of the Company.
