The Company’s main activities have included managing its on-going IPF and chronic cough Phase 2 clinical trial as well advancing its DMT Stroke research program.

On July 6, 2021, the Company announced that it will not be advancing Ifenprodil into a Phase 3 clinical study for COVID-19. The Company’s decision was based on several factors including the overall findings of the Phase 2b COVID-19 study final data set, the global rate of vaccinations to date, other COVID-19 drug treatment programs under development, and the projected trial size, costs and timelines needed to successfully complete a Phase 3 trial. Feedback recently received from the U.S. Food and Drug Administration regarding the Company’s end of Phase 2 meeting request was also informative.

On July 7, 2021, company, announces that it has reached 70% of its enrollment target for its Phase 2 clinical study of its re-purposed drug NP-120 (Ifenprodil) for idiopathic pulmonary fibrosis (IPF) and chronic cough.
