The Company’s main activities have included managing its on-going IPF and chronic cough Phase 2 clinical trial as well advancing its DMT Stroke research program. In addition, the Company expanded its clinical cancer research program to include small cell lung cancer.

On August 9, 2021, the Company announced that it has signed an exclusive licensing agreement with Dartmouth College to acquire the rights to a method of use patent for treating neuroendocrine cancers which express functional N-methyl-D-aspartate receptors.

On August 11, 2021, the Company announced that it has initiated an NP-120 (“Ifenprodil”) small cell lung cancer research program and has appointed Dr. William North, professor emeritus at Dartmouth College and cancer research pioneer, as lead consultant. SCLC is a high-grade neuroendocrine carcinoma arising predominantly in current or former smokers and has an exceptionally poor patient prognosis.
