March 13, 2018 – Vancouver, B.C. – Alliance Growers Corp. (CSE: ACG; FWB: 1LA; WKN: A2DFYX) (“Alliance Growers” or the “Company”) is pleased to announce that it has entered into a Business Development Services Agreement with Mr. Stuart Gray that also includes the provision of certain Public Relations Services.

Mr. Gray has 22 plus years of experience in business and marketing. He has founded several media and promotional related companies and has provided consulting to over 100 public companies in the USA and Canada. Stuart’s services have ranged from reverse mergers, marketing, branding, social media and financings. Stuart has provided consulting to several Marijuana-related Companies since 2014.
