- ✦ Multiple Voter IDs will have to be entered separately at the time of voting

- ✦ If you don't have a computer, tablet or smartphone, or if internet access is not an option, you may call into the meeting
- ✦ Telephone access will be 'listen only'
- ✦ Telephone participants SHOULD vote by proxy, as noted above, prior to the meeting
