The gross proceeds from the sale of the FT Units will be used by the Issuer to incur eligible "Canadian exploration expenses" that will qualify as "flow-through mining expenditures" as such terms are defined in the *Income Tax Act (Canada)* (the "**Qualifying Expenditures**") related to the Issuer's projects in Canada. All Qualifying Expenditures will be renounced in favour of the subscribers of the FT Units effective December 31, 2020. It is anticipated that most of the funds derived from the sale of the FT Units will be used to explore the Issuer's recently acquired Belvais project.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
