Each Warrant is exercisable at a price of \$0.40 for a period of 24 months from the date of issuance. The First Tranche forms part of the Private Placement of up to 12,000,000 Units.

Issued and outstanding securities following issuance: 58,844,506 common shares upon closing of the First Tranche and up to 66,058,506 upon closing of all tranches of the Private Placement.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:
