- (d) The amounts due to or from Related Persons and the terms and conditions relating thereto. **The CEO is not drawing any fees, which are accumulating at \$5,000 per month, with \$553,306 owing to him at December 31, 2016. The independent directors were owed \$51,000 for unpaid Directors' fees. Canada Enerco Corp., a company controlled by Tom Drivas, is owed \$29,658 for expenses paid on behalf of the Company in 2007.**
- (e) Contractual obligations with Related Persons, separate from other contractual obligations. **There is a service agreement with the CEO entitling him to \$5,000 per month. The CFO is paid according to his time spent on the Issuer's affairs.**
- (f) Contingencies involving Related Persons, separate from other contingencies. **In the case of change of control of the issuer, there is a severance payment due to the CEO and CFO.**

On December 30, 2016, the Company completed a non-brokered private placement with the sale of 1,301,000 flow-through shares ("FT Shares") at \$0.18 per FT Share for gross proceeds of \$234,180. The Company paid cash finder's fees of \$18,014 and issued 100,080 broker warrants. Each broker warrant entitles the holder to acquire a common share of Appia at \$0.18 until December 30, 2018. An insider of the Company subscribed for 50,000 FT Shares.
