*The Issuer is an exploration stage company whose primary activities are acquiring and exploring mineral properties. Currently the Issuer has no mineral properties and is currently inactive. The Issuer is actively pursuing and doing due diligence on a potential property acquisition.*

**There were no significant developments or operations on the Issuer's properties in the month of August 2018.**

**On November 4, 2013 the Company was issued a cease trade order for failure to file its annual audited financial statements, management discussion and analysis and certifications for the year ended May 31, 2013 and interim financial statements, management discussion and analysis and certifications for the three months ended August 31, 2013 (the "Financials"). The Company was unable to acquire a legal opinion from Brazil for 2013 regarding the status of a tax default penalty, if any. Without this legal opinion, the Company was unable to satisfy the auditor's requirements. The Company no longer holds the Brazil Properties but is still unable to file the Financials and was also unable to file the six-month financial statement for the period ended November 30, 2013 and the nine month financial statement for the period ended February 28, 2014. The Company was unable to complete the audited financial statements for the year ended May 31, 2014 and was unable to file the financials for the three months ended August 31, 2014, the six months ended November 30, 2014, the nine months ended February 28, 2015, the audited financial statements for the year ended May 31, 2015, three months ended August 31, 2015, six months ended November 30, 2015, nine months ended February 29, 2016, year ended May 31, 2016, three months ended August 31, 2016 and six months ended November 30, 2016 (above financial statements referred to as "the Unfiled Financial Statements"). Management is still working on rectifying these deficiencies and filing the Unfiled Financial Statements. Management is concentrating its efforts on raising funds for further development of the Issuer's projects and general working capital. The Company continues to look at potential opportunities for the Company. Mr. Kjosness has been actively pursuing and doing due diligence on a potential property acquisition.**

**Resource exploration and development is a speculative business and involves a high degree of risk, including, among other things, unprofitable efforts resulting not only from the failure to discover mineral deposits but from finding mineral deposits which, though present, are insufficient in size to return a profit from production. The marketability of natural resources that may be acquired or discovered by the Issuer will be affected by numerous factors beyond the control of the Issuer. These factors include market fluctuations, the proximity and capacity of natural resource markets, government regulations. The exact effect of these factors cannot be accurately predicted, but the combination of these factors may result in the Issuer not receiving an adequate return on invested capital. The great majority of exploration projects do not result in the discovery of commercially mineable deposits of ore. Even if commercial quantities of mineral deposits are discovered by the Issuer, there is no guarantee that a profitable market will exist for the sale of the metals produced.**

**The development of the Company's properties will depend upon the Issuer's ability to obtain financing through the joint venturing of projects, private placement financing, public financing or other means. There can be no assurance that the Issuer will be successful in obtaining the required financing.**
