Subsequent to completion of a standard ninety (90) day evaluation period at two separate locations (one in North Carolina and one in North Dakota), ASTI has been awarded the business at both locations. Each will take delivery of one of ASTI's new portable lasers for bladder and kidney stones. Moving

forward, they will purchase single use fibers (one per procedure) from ASTI on a monthly basis and each facility performs approximately 25 procedures per month, representing a profitable recurring revenue stream for ASTI for many years to come.

Furthering expanding on ASTI's market presence and sales potential, ASTI has recently signed up a senior, experienced sales team working out of Charlotte, North Carolina. With over 20 years experience in the urology marketplace, including operating room experience, this well respected and dedicated sales team has an established clientele base, and will definitely increase ASTI's exposure to prospective clients and boost sales for ASTI's lasers and consumable fibers.

In addition to the above, management of the Issuer continues to approach Brokers and HNW Investors to spread the story and attract investment in the ASTI.

Further, management is in discussions with several Sales and Factoring organizations both in Canada and the United States about putting a working capital facility in place for the Issuer. Hopefully, this will occur shortly. Sales continue to be hampered by lack of working capital.
