Further to its news releases dated February 26, 2021 and March 22, 2021, the Issuer has completed the acquisition of all of the shares of AmTek Inc. in consideration for the issuance of 12,000,000 common shares of the Company. The Issuer also issued 960,000 common shares of the Company to a finder in consideration for the finder introducing the parties to the Transaction. Such shares are subject to a hold period of four months and one day.

April 15, 2021

The Issuer has commenced a high resolution, 25m line spaced 900km long heliborne magnetometer survey on its 100% owned Whabouchi South Project.

April 21, 2021

The Issuer announced that it plans to change its name from "Soldera Mining Corp." to "AmmPower Corp.", and its ticker symbol from "SOLD" to "AMMP", subject to the approval of the Canadian Securities Exchange.
