***BIG Blockchain Intelligence Group Inc.** ("BIG" or the "Company") (CSE: BIGG) has developed from the ground up a Blockchain agnostic search and analytics engine allowing Fintech, Regtech, Law Enforcement & Government Agencies to trace, track and monitor cryptocurrency transactions at a forensic level. Our commercial product, BitRank*

Verified™, offers a “risk score” for bitcoin wallets allowing banks, exchanges and eCommerce sites to meet traditional regulatory/compliance requirements.

During March 2019, management continued its business and marketing initiatives to increase the Company’s exposure within the Fintech/Regtech sectors, build corporate name recognition and broaden general awareness.

The prices of cryptocurrencies, in particular Bitcoin, have declined steeply since the all-time highs of late 2017. Despite this fall in prices, the sector is expected to experience growth in trading volumes during 2019. The cryptocurrency market, which has now entered into the longest ever bear market, is expected to remain highly volatile throughout 2019 and likely beyond.
