Report on Business

The Issuer, an agriculture technology company, is a market disruptor with a significant global market opportunity in the \$240 billion crop protection and fertilizer market. The Issuer has pioneered a natural precision agriculture system that replaces chemical pesticides and wasteful plant protection product spray applications by delivering biological pesticide alternatives to crops using commercially grown bees. The Issuer's award-winning technology, precision vectoring, is completely harmless to bees and allows minute amounts of naturally-derived pesticides (called biologicals) to be delivered directly to blooms, providing improved crop protection and yield results than traditional chemical pesticides - and improving the health of the soil, the microbiome and the environment. Currently, the Issuer has over 65 granted patents, over 35 patents pending in all major agricultural countries worldwide, and has US EPA registration of its VECTORITE™ with CR-7 (EPA Registration No. 90641-2) for sale as a registered biological fungicide for use on the labelled crops.

2. Provide a general overview and discussion of the activities of management.

During the month of March 2021, management's principal activities consisted of:

- the filing of the Issuer's first quarter interim financial statements and MD&A for the quarter ended December 31, 2020;
- announcing a progress update for entry into Europe, including key investments to accelerate timelines, including establishing an R&D center and European office in Switzerland's Agri & Co Innovation Center, discussions with potential partners in Europe covering product access and commercial go-to-market arrangements, targeting adjacent countries which export significantly to the EU market and the preparation for submission for the EU regulatory approval of its proprietary biological plant protection product CR-7;
- announcing the start of the first grower trials in the Issuer's largest single crop opportunity in the US, the California almond market;
- providing an update on rapid acceleration of revenues in the 2021 fiscal year;
- announcing that the Issuer has been granted a US patent for the latest version of its honeybee hive dispenser system;
- advising of the resignation of Brandon Boddy from the Issuer's board of directors effective April 1, 2021; and
- attending to general administration matters.

3. Describe and provide details of any new products or services developed or offered. During the month of March, 2021, the Issuer announced its first grower trials in almond crops in California. The Issuer has begun trials with five almond key growers and key crop advisors in the main almond growing region in the state, the Central Valley.

The Issuer announced that it has been granted a US patent for the latest version of its honeybee hive dispenser system. The new system is computer-controlled and enables metered, uniform delivery of plant protection products to crops using commercial honeybees. This is the first patent on its honeybee dispenser system, and represents the first patent in a fifth overall area of technology of the Issuer.

COVID-19

The outbreak of the corona virus pandemic has impacted the Issuer's plans and activities. The Issuer may face disruption to operations, supply chain delays, travel and trade restrictions and impact on economic activity in affected countries or regions can be expected and can be difficult to quantify. Such pandemics or diseases represent a serious threat to maintaining a skilled workforce industry and could be a major health-care challenge for the Issuer.
