On January 30, 2020, the World Health Organization declared the COVID-19 outbreak a global health emergency, and on March 20, 2020 the government of Indonesia implemented additional travel restrictions. Global government actions, including these restrictive measures in Indonesia, along with market uncertainty,

could cause an economic slowdown resulting in a decrease in the demand for metals and have a negative impact on metal prices, as well as possible disruptions to global supply chains. While these effects are expected to be temporary, the duration of the business disruptions internationally and related financial impact, cannot be reasonably estimated at this time.
