The Issuer's key asset is the Cyclops Cobalt-Nickel Project (the "Cyclops Project" formerly the "TNM Project"). The Cyclops Project is named for its close proximity to the Cyclops mountain range and is situated on the north coast of Papua Province, Indonesia.

The Issuer continues to receive results from drilling which it expects to disclose regularly through the balance of 2019.
