On February 10, 2026, the Company announced enhancements to its investor relations program, including the engagement of Plutus Invest & Consulting GmbH and the renewal of agreements with i2i Marketing Group, LLC and Native Ads, Inc. The engagements are intended to strengthen shareholder communications and market awareness initiatives. The firms are arm's length to the Issuer and the arrangements provide for cash compensation only. No securities were issued in connection with the engagements.

During February 2026, management's activities included implementing and
