NameSilo Technologies Corp. (the "Issuer") invests its capital in companies and opportunities which management believe are undervalued and have potential for significant appreciation. The Issuer makes investments in both public and private markets and focuses on opportunities in a wide variety of industries excluding the resource and resource service sectors.

Throughout the month of April, the Issuer remained in contact with management of Vigil Health Solutions Inc. ("Vigil"), Lite Access Technologies Inc. ("Lite Access"), ImmunoPrecise Antibodies Ltd. ("ImmunoPrecise"), and Pioneering Technologies Corp. ("Pioneering").

Upon completion of its acquisition of NameSilo, LLC ("NameSilo"), the Issuer is now a provider of domain name registration services and marketplace services for the buying and selling of domain names.

2. Provide a general overview and discussion of the activities of management.

Management was actively engaged in all general administrative and sundry duties of the Issuer, and focused on creating strategic relationships. The Issuer also remained in contact with management of Vigil Health Solutions Inc., ("Vigil") Lite Access Technologies Inc. ("Lite Access"), ImmunoPrecise Antibodies Ltd. ("ImmunoPrecise"), and Pioneering Technologies Corp. ("Pioneering").

On April 8, 2019, the Issuer reported that NameSilo was the second fastest growing domain registrar on earth in the month of December 2018. NameSilo added 205,544 net new domains in December 2018, which represents a 247% increase from the 59,238 net new domains added in December 2017.

On April 30, 2019, the Issuer announced the launch of Web Hosting and Email to

its growing list of value-add offerings. These new services are in direct response to NameSilo clients' desire for a one-stop source for essential services related to their domains. Additional services are slated for roll-out later in the calendar year. Features of these new hosting services include up to: 60 GB of storage, 10 websites and unlimited Freemium Email. Freemium email included with hosting plans include: Email forwarding, vacation responder and filters, advanced anti-spam and 99.9% uptime, integrated calendar and contacts, and video calling.
