CanaFarma also appointed Djibril Gibson Kagni as Head of Media Management.

During the month of July, management continued to pursue the company strategy of building out a farm to table company and significantly progressed its due diligence and negotiations to purchase Pharm Ops as previously outlined in a non-binding LOI which was signed in April.
