The disclosure should be sufficiently complete to enable a reader to appreciate the significance of the transaction without reference to any other material: Pursuant to an Asset Purchase and Contracts Assignment Agreement to be dated and entered into on December 1, 2020, CEG's Chilean subsidiary Minera Til Til SpA ("Til Til") will acquire from Minera Tamidak Limitada ("Tamidak") the mining concessions and other assets covering the Pimentón Copper Gold Mining Project as well as Tamidak's rights and obligations under the Exploration and Option to Joint Venture Agreement entered into on or about April 27, 2020 between Tamidak and FQM Exploration (Chile) S.A., a Chilean subsidiary of First Quantum Minerals Ltd.

  - (a) Total aggregate consideration in Canadian dollars: Approximately CDN\$6,608,265 (3.9 billion Chilean pesos), payable in three equal instalments of 1.3 billion Chilean pesos each, with the first instalment (approximately CDN\$2,202,755) payable in Common Shares of the Issuer (44,055,102 Common Shares) on December 1, 2020 at a price per share of CDN\$0.05, and the second and third instalments payable in cash or its equivalent in Common Shares of the Issuer, as Tamidak may elect in its sole and absolute discretion, at a price per share equal to the greater of (A) the simple average of the closing price per Issuer Common Share on the CSE for the 10 consecutive trading days ending on the date immediately prior to such payment being made; and (B) CDN\$0.05 per share (or such other minimum price per share as may be in effect pursuant to the policies and rules of the CSE at the relevant time) no later than the 18-months' anniversary of the date of the APA, in the case of the second instalment, and no later than the 36 months' anniversary of the date of the APA, in the case of the third instalment.

The first instalment of the purchase price will be paid by issuing 44,055,102 Common Shares of the Issuer. ### PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
