The processor holds a Type 6 (non-volatile solvent extraction) licence from the State of California. The processor uses Apeks supercritical CO2 (carbon dioxide) extraction to produce cannabis oil, terpene profiles and other products on behalf of cannabis cultivators, other manufacturers and processors throughout northern California. Chemistree expects to finance the loan from its existing cash on hand. In addition, in consideration for benefits received by Chemistree under the collaboration, it has agreed to issue 100,000 common shares to the principal of the processor.

Chemistree will lend the processor \$450,000 (U.S.) and the parties also intend to negotiate an additional line of credit for working capital purposes. Chemistree expects the processor will use the proceeds of the loan for business expansion, including to, among other things, purchase additional equipment and make tenant improvements to its facility. Chemistree will also work with the processor to purchase cannabis biomass on a proprietary basis and process that biomass to ultimately be sold as a Chemistree- or Sugarleaf-branded product
