Report on Business

Management was active during the month continuing with the improvement of the assets contained within the Washington Acquisition, and the integration of those assets into corporate operations. Advanced planning continues for the expansion

of the facility, and the establishment of an extraction, processing and manufacturing operation.

In addition, the Issuer completed the filing of the of the application for a Continuous Use Permit ("CUP") application for the DHS Property acquired in August 2018.

Management and the Board attended the MJBizCon Conference and Expo Las Vegas, the premier marijuana business conference in North America. During MJBizCon the Company sponsored the High Times "Biz Bash" party, featuring 2 Chainz. The Biz Bash was be held Thursday, November 15, 2018 at the Brooklyn Bowl, Las Vegas. The sponsorship of High Times and the recent launch of the new Sugarleaf website is part of an aggressive marketing and sale campaign to introduce Chemistree Technology to all cannabis retailers starting with over 3,300 retail dispensaries and cultivation with the majority located in California, Colorado, Arizona and Nevada.

The Company also announced that it had successfully concluded negotiations to enter into a strategic collaboration (the "Collaboration") with a Humboldt County-based cannabis processing company (the "Processor") located in Arcata, California. Pursuant to the Collaboration, Chemistree will loan the Processor US\$450,000 (the "Loan"), and the parties also intend to negotiate an additional line of credit for working capital purposes. Chemistree expects the Processor will use the proceeds of the loan for business expansion, including to, among other things, purchase additional equipment and make tenant improvements to its facility.

The Processor holds a "Type 6: Non Volatile Solvent Extraction" license from the State of California. The Processor uses Apeks super critical CO2 extraction to produce cannabis oil, terpene profiles and other products on behalf of cannabis cultivators, other manufacturers and processors throughout northern California.

Chemistree expects to fund the Loan from its existing cash on hand. In addition, in consideration for benefits received by Chemistree under the Collaboration, it has agreed to issue 100,000 common shares to the principal of the Processor.

The Company concluded the process to make its common shares are eligible for electronic clearing and settlement through the Depository Trust Company ("DTC") in the United States.

The Company has engaged a digital marketing firm to provide improve and expand the Company's investor relations and public relations reach. This will be an ongoing addition to the Company's business with the specific aim to providing improved shareholder information flow as well as providing greater awareness of the company's growing product lines and any new avenues of business and investment.

The Company wishes to inform shareholders that there are significant legal restrictions and regulations that govern the cannabis industry in both Canada and the United States.

Strict compliance with state laws with respect to cannabis will neither absolve the company of liability under U.S. federal law, nor will it provide a defence to any federal proceeding which may be brought against the company. Enforcement of U.S. federal laws will be a significant risk to the business of the company following the completion of the acquisitions, and any such proceedings brought against the company, may adversely affect the company's operations and financial performance.

The Company is comfortable with its near-term cash position and it is confident that the broad acceptance of cannabis-focused companies as exciting investment opportunities in Canada will expand to include companies like Chemistree focused on the far larger market available in those individual American states where cannabis is medically and/or recreationally legal. The Company's investigation into these opportunities continues, and, should any one of these opportunities mature, Chemistree may be required to make certain filings and changes to the company's listing disclosure under the requirements of Canadian Securities Exchange policies.

As announced, the Company sees the cannabis industry as a source of focus. The reason for this is simply that marketing of cannabis companies, their products as well as information about the industry itself is in its infancy. Initially, the Pacific Northwest will be the Company’s main target geography, but this is expected to expand from British Columbia and Washington state into California.

The Company wishes to inform shareholders that there are significant legal restrictions and regulations that govern the cannabis industry in both Canada and the United States.
