As part of a planned transition, the Company also appointed Dennis Olis to replace Mr. Amann as Chief Financial Officer (“CFO”), effective July 1, 2020. Mr. Olis joins Cresco Labs after previously serving as CFO for Allscripts Healthcare Solutions. Mr. Amann will remain in an advisory role through the remainder of 2020 to ensure a smooth transition of responsibilities.
