On June 21st, 2021, the Company announced the opening of Sunnyside Philadelphia, its 4th dispensary in the state of Pennsylvania and 33rd operating U.S. store. The medical-only cannabis store is located at 1221 Chestnut St. in Philadelphia.

Issuer Response: Management has been actively involved in managing operations and revenue growth, acquiring talent, and exploring and evaluating expansion opportunities.

Issuer Response: On June 9th, 2021, the Company announced the portfolio expansion of its Good News brand. Under its social occasion-based Good News brand, Cresco is launching Counting Sheep, Day Off and Pride products in edible and vape forms in California, Illinois, and Michigan. Counting Sheep represents the Company's first product made with CBN. Day Off is a product featuring CBD, and Pride, a Sativa-forward product, is available for a limited time during June Pride month in select markets.

The campaign will amplify the ongoing restorative justice, community business incubator and education and workforce development programming facilitated by the Company's established SEED (Social Equity & Education Development) initiative.
