The Company is preparing to receive clones and begin growing cannabis at the Dorval facility. The Company continues to make progress on the greenhouse project in Hemmingford Quebec. The Company plans to build 1,000,000 sq ft of greenhouses on the 181 acre farm in Hemmingford in 200,000 sq ft increments.

Matica and Yunify Natural Technologies ("Yunify") working to quickly bring our new product into the consumer market place. Yunify has developed a spray mist that captures odours through Yunify's Natural Ions Encapsulation technology; odours are trapped and they are neutralized. After spraying an area, the odour disappears and the sprayed area is left smelling clean and fresh. The product can be used as a personal spray and is also being developed as a room deodoriser.

Management is continuing to make preparations to receive clones and begin growing cannabis at the newly licensed growing facility in Dorval.
