Interest is charged on the outstanding balance of the loan facility at Bank's prime rate plus 1.25% calculated on a daily basis and paid monthly. The outstanding balance of the loan facility was \$3.2M as at May 31, 2018. The outstanding balance of the loan was increased by \$4.2M during the month of June, 2018, bringing the outstanding balance of the loan facilities to \$7.4M as at June 30, 2018.


