The Issuer has a demand loan facility with the Bank of Montreal. Interest is charged on the outstanding balance of the loan facility at Bank's prime rate plus 1.25% calculated on a daily basis and paid monthly. The outstanding balance of the loan facility was \$7.7M as at August 31, 2017. The outstanding balance of the loan was increased by \$2.6M during the month of September, 2017, bringing the outstanding balance of the loan facilities to \$10.3M as at September 30, 2017.


