Copland Road Capital Corporation (the "Company" or the "Issuer") is a Canadian investment company. The Company announced that it had filed articles of amendment to change the Company name to "Copland Road Capital Corporation". It commenced trading under the new name "Copland Road Capital Corporation" on January 14, 2022, under the Company's new symbol "CRCC". The Company's previously issued Senior Unsecured Notes have now been

delisted. As well, following the implementation of the creditor proposal on January 26, 2021, all of the Company's previously issued common shares, stock options, debentures and warrants were deemed null and void.

Management of the Issuer was principally engaged in continuing to streamline its corporate structure and evaluate capital management opportunities. During the month of July 2022, the Company incorporated five (5) wholly-owned subsidiaries, namely Bothwell Road Capital Corp., Broomloan Road Capital Corp., Edmiston Drive Capital Corp., Goram Capital Corp. and James Bell Capital Corp.
