The Corporation has entered into loan agreements with a syndicate of lenders for a total of One Hundred Seventy Five Thousand Dollars (“\$175,000.00”) CDN. Under the terms of the agreements the Corporation will pay Twelve percent (“12%”) per interest per annum to the lenders and repay the loan over three (“3”) years. The Corporation will also issue a combined Twenty-Six Million, Two Hundred and Fifty Thousand (“26,250,000”) Units of the Corporation to the syndicate. Each unit shall consist of One (“1”) Common Share of the Corporation and 1 full Purchase Warrant. Each Purchase Warrant shall entitle the holder of the Warrant the ability to purchase 1 additional Common Share at a deemed price of Five Cents (“\$0.05”) CDN per Common Share for a period up to three years after the date of issuance of the Units
