On April 13, 2021, the Issuer issued a news release announcing that it had acquired, subject to West Virginia state regulatory approval and customary closing conditions, (the "Acquisition") Solevo Wellness West Virginia LLC ("Solevo") and its three West Virginia dispensary permits for US\$650,000. Solevo was awarded two permits in Morgantown and one in Parkersburg in January 2021 as part of the West Virginia application process. On June 9, the Issuer issued a news release confirming the closing of the Acquisition.

## Appendix A

### PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:
