  - **Managing its portfolio of hydro assets, currently aggregating 46.3MW of operating capacity spread over 2 investments with 4 hydro plants in Nigeria.**

  - **The Issuer filed its Q2 2020 audited financial statements for the 3- and 6-month period. Financial results for the six-month period included revenue of \$990,236, G&A expense of \$134,637 and net income of \$1,142,595.**
  - **The Issuer consolidated its shares on a 100:1 basis, reducing common shares outstanding from 575,347,377 to 5,753,474.**

As a result, the Issuer is more flexibly managing its treasury across its CAD, USD and NGN accounts.**
