 - In a press release dated July 5, 2021, the Issuer announced delays in preparing its financial statements for the fiscal year ended December 31, 2020 (the "Annual Financial Statements") and related MD&A and officer certifications (collectively, the "Annual Filings").
 - On December 10, 2021, the Issuer filed its Full Year 2020 audited financial statements. Financial results for the twelve-month period included revenue of \$3,295,459, G&A expense of \$672,620 and net income of \$1,965,264.
 - On December 23, 2021 the Issuer filed its Q1 2021 financial statements, including revenue for the three-month period of \$353,124; its Q2 2021 financial statements, including revenue for the three-month period of \$458,467; and its Q3 2021 financial statements, including revenue for the three-month period of \$0.
 - Upon making the above-mentioned Annual Filings and quarterly filings, on December 24, 2021 the Issuer made an application with the BCSC and the OSC to be released from the Cease Trade Order imposed as result of late filing of its financial statements. The issuer awaits a decision on its FFCTO release application.

This dispute is ongoing.**

Earlier in 2021, the Corporation successfully exchanged a portion of its Nigerian funds into dollars, although the FX rate was well below levels prevalent in 2020.**
