Blackx Management is engaged to provide corporate advertising, communication, translation, market advisory, investor relations for Sweet Earth Corporation for a period of six months. This includes preparing and advertising campaign for the Company's European capital market and product distribution in Germany.

Sweet Earth was given the option to pay \$80,000 per month for 6 months or a one-time payment of \$390,000. Given the savings, the company opted for the one-time payment, which saves \$90,000.
