("Brisco") for Brisco, through its agent Scott Kyoich, to perform investor relations activities including communications with and marketing to investment advisors, shareholders and media contacts. As compensation, the Issuer has agreed to pay Brisco \$7,500 per month for a six month term and grant to Brisco 300,000 incentive stock options exercisable at \$0.55 per common share over a two year term, that are subject to a 12 month vesting period with 25% of the options vesting every three months.
