The Issuer proposes to consolidate its outstanding common shares, on the basis of one (1) post-consolidation common share for every eighty (80) pre-consolidation common shares. Fractional Shares resulting from the proposed share consolidation will be rounded to the nearest whole number of common shares.

2. Number of securities outstanding and reserved for issuance following the reclassification

As of the date hereof, the Issuer has 153,199,573 common shares issued and outstanding, and 41,851,400 common shares reserved for issuance upon the exercise of outstanding stock options. As a result of the proposed consolidation, the Issuer anticipates there will be a total of approximately 1,914,995 Common Shares issued and outstanding, and a total of 523,143 common shares reserved for issuance upon the exercise of existing stock options, not including rounding for any fractional amounts resulting from the proposed consolidation.

3. Describe the anticipated impact of the reclassification on the liquidity of the market for the listed security and on voting and equity rights of public shareholders

The Issuer does not anticipate that the proposed consolidation will have any affect on the liquidity of the market for the common shares or on the voting and equity rights of its public shareholders.

4. Date of shareholders' meeting to approve the reclassification

Not applicable. Pursuant to the provisions of the Articles of the Issuer, shareholder approval is not required for the proposed consolidation.
