The Issuer is engaged in the exploration and evaluation of the Martison phosphate project (the "Project"), which is located about 70 kilometers northeast of the town of Hearst, in north-central Ontario and is close to rail,

power, highway, and other infrastructure. The Project contains a major carbonatite (igneous carbonate-rich) pipe capped by a residual deposit (residuum) enriched in phosphate and niobium minerals. The Project mining leases and claims cover a contiguous area of approximately 8,256 ha.

There was no exploration and evaluation work done during the month of March 2019.
