Acreage Holdings, Inc. ("Acreage" or the "Issuer") is headquartered in New York City, New York, with a registered office at Suite 2800, Park Place, 666 Burrard Street, Vancouver, British Columbia, and is the largest vertically integrated, multi-state owner of cannabis licenses and assets in the U.S. with respect to number of states with operating licenses. With licenses to operate or management services

or consulting agreements in place with license holders to assist in operations in 20 states (including pending transactions), we serve a population of more than 172 million Americans, and an estimated 2022 total addressable market of approximately \$17 billion in legal cannabis sales according to Arcview Market Research. Acreage is dedicated to building and scaling operations to create a seamless, consumer-focused branded cannabis experience.

 - On May 8, 2019, Acreage announced the appointment of Christine Rigby as Vice President, Investor Relations.
 - On May 13, 2019, Acreage announced that it entered into a letter of intent with GreenAcreage Real Estate Corp. negotiated at arm's length, under which GARE would purchase and lease back to Acreage cannabis related real estate assets.
 - On May 23, 2019, Acreage announced that it filed a management information circular relating to the proposed acquisition of Acreage by Canopy Growth Corporation, pursuant to a court-approved arrangement under the *Business Corporations Act* (British Columbia).
