On March 8, 2021, the Issuer announced the appointment of Elkouby Nisim to its board of directors, and the appointment of four new executives to its management. Please refer to the Issuer's press release dated March 8, 2021 for additional details.

On March 8, 2021, the Issuer announced that it has granted 900,000 options to purchase subordinate voting shares to certain employees, officers, director and consultants pursuant to its option plan. On March 25, 2021 the board unanimously approved the granting of 100,000 options to Vered Elkouby Nisim.

The Issuer is one of three defendants named in an action commenced by Rees Baron, as plaintiff, on November 29, 2018 in the Supreme Court of British Columbia under Vancouver Registry No. S-1812770. The plaintiff has claimed CDN \$120,000 from the Issuer, Vapergy International, LLC and Brent Skoda pursuant to an alleged finder's fee agreement among the parties. The Issuer is contesting the claim and filed its Response to Civil Claim on December 21, 2018. Vapergy International, LLC and Brent Skoda filed their Response to Civil Claim on July 5, 2019.

The Issuer is also one of a number of defendants in an action commenced on July 13, 2020 by Curtis Heffernan, a former officer of the Issuer, in the Superior Court for the State of California (County of Los Angeles) under case number 20STCV25549. The plaintiff has made certain claims against the Issuer with respect to matters concerning his departure and the Issuer is planning on defending the action.

On February 26, 2021, a complaint was filed in the Southern District Court of Florida - JHO INTELLECTUAL PROPERTY HOLDINGS, LLC et al v. Ignite International, Ltd. et al. The plaintiff alleges trademark infringement of its mark SRO by the Issuers energy drink Z-RO. The complaint also alleges the Issuer induced a former employee of the plaintiff to breach the non-compete agreement provisions of their contract while working for the Issuer.

Between June 8, 2020 and February 28, 2021, 5 convertible promissory notes totally \$16,850,000 were entered between the Company and International Investments, Ltd., which employs one of the Directors (Greg Gilpin-Payne) of the Company. The conflict was not discovered until March 25, 2021. Greg Gilpin-Payne did not vote as a director with respect to any of the aforementioned loans. To ensure there is no appearance or actual conflict going forward, the Company is removing Mr Gilpin-Payne from the Board.

Vered Elkouby Nisim was appointed to the Board on March 8, 2021.
