During the month of January 2017, the Issuer executed upon its business plan and announced that it advanced towards its Compliant Operator Certificate by formalizing an agreement to expand its testing from the Waterloo region to now include a second province, namely, Foremost Alberta - Canada's first Transport Canada approved drone UAV test range in Canada. The issuer is in advanced discussions with multiple significant partners to test, develop and integrate its drone delivery logistics platform.
