Technical and software enhancements were developed in the month of July to create a digital framework that simplifies the way third party integration partners can connect to the issuer through direct API connectivity.

The issuer continued to work on product development for the North American retail markets including integrations into leading retail partners for merchant funded rewards and benefits.

In July the issuer announced two new customer/partnership contracts:

1. **Stramit Corporation Pty Ltd: EONX will receive transaction fees on VISA and MASTERCARD payment processing, and process all marketplace rewards points and transactions on its platform. EONX will also receive a software platform fee of \$625,000 including \$355,000 payable in the first two years of the contract period and an additional two-year option for a further \$270,000.**

2. **Mastercard Loyalty Solutions: EonX will facilitate the end-to-end creation, distribution, stock management, warehousing and fulfilment of digital and physical gift cards. EonX is reviewing the business case to budget for anticipated monthly volumes and will make further announcements to the market in due course.**

Management monitored and implemented performance measures to outline departmental Key Performance Indicators and sales targets.
