During the month of June 2019, the Issuer completed the following milestones, through Opco (defined below):

Opco is in the final installation phase of a proper ventilation system in the Makish extraction facility. Due to unexpected delays, it is expected to be fully functional through mid-July. Extraction facility team lead by Prof. Dr. Bojan Mitic, optimized extraction process for increased quality and consistency of final product. The facility and the team are ready for production. Opco is preparing to start 2nd & 3rd shift after ventilation system is place.

2. Provide a general overview and discussion of the activities of management.

The Company continued to explore potential partnerships for extraction of the current hemp in inventory. In the prior months, management explored facilities in Romania and Macedonia in search of a partner with available capacity to extract and produce CBD in the near term.

The company continues to have discussions with ICC. As the previously proposed “Hemp Transaction” lapsed, the two sides continue to communicate regularly.

By instruction from ICC Wayland Expert team from Germany visited Eviana facilities in Belgrade to perform an inspection and business due diligence, and they left the Eviana premises with satisfaction. This visit was during the last week of June 2019.
