**On March 3, 2017, the Company has announced that a non-brokered private placement has been arranged for up to 10,000,000 units. Each unit consists both of one common share and one common warrant. The price was set at \$0.05 per unit for a total of \$500,000.**

Each whole warrant can be converted into one common share at a price of \$0.065 per share which is exercisable within 24 months.

On March 11, 2017, The Company informed that it has closed the said private placement. It was oversubscribed by \$100,000 and a total of 12 million common shares were issued. In total, gross proceeds were \$600,000 with a unit price of \$0.05

The proceeds will be used for the Company's general working capital and potential acquisitions.
