During the month, the Issuer completed the following milestones, through Opco (defined below), whom the Issuer has the exclusive option to acquire:

In March 2018, Opco continued necessary adjustments and site and adaptation for HACCP certification in its purchased production facility of 40,000 sq. ft. in the village of Mladenovo, a centre of Cannabis Sativa growing, situated approximately 180 Km from the head office in Belgrade-Dobanovci. During this period, Opco continued the adaptation of its facility in order to address technical matters relating to the production process. Opco also worked to winterize the storage part of the facility and herb processing part with testing and adjustments of technology work flow. .

In March, Opco continued with land preparation for seeding in April 2018. Opco has prepared approximately 200 Ha of land.

Preparation and construction of the Extraction facility continues while Opco is still working to obtain a provisional production license and an installation safety and fire permit.

The Issuer holds an option to acquire Eviana Inc., an Ontario corporation (“Opco”) with a hemp farming operation in Serbia. Management of the Issuer has been actively involved in monitoring and supervising the operations and the harvest of the hemp crop as well as sourcing requisite equipment for processing the hemp into CBD’s. During the month, management was involved in speaking with the financial community interested in its corporate developments and

progress. Management has also been involved in speaking with companies interested in purchasing and distributing CBD's extracted from hemp.
