During the month of May 2019, the Issuer completed the following milestones, through Opco (defined below):

Opco continued to work on necessary site adjustments, site planning, site infrastructure adaptation and preparation for storage capacity upgrade, as well as undergoing HACCP & GMP certification in its production facility in the village of Mladenovo, a centre for Industrial Hemp growing. During the former month period, Opco continued the adaptation of this facility in order to address technical matters related to the production optimization and storage capacity along with storage viability, and environmental and humidity control system.

Opco finished planned sowing for 2019 season utilizing maximum field capacity.

Furthermore, Opco is in the final installation phase of a proper ventilation system in Makish extraction facility, expected to be fully functional through mid-June. Extraction facility team lead by Prof. Dr. Bojan Mitic, optimized extraction process for increased quality and consistency of final product. The facility and the team are ready for production. Opco is undergoing process to obtain a full extraction license. Extraction facility has started with employee work schedule adjustments, due to satisfactory test production output. Opco is preparing to start 2nd & 3rd shift.

In May 2019, the Company continued to explore potential partnerships for extraction processing of the current hemp in inventory. In the prior month,

management explored facilities in Romania and Macedonia in search of a partner with available capacity to extract and produce CBD in the near term.

The company continues to have discussions with ICC. As the previously proposed “Hemp Transaction” lapsed, the two sides continue to communicate regularly.
