Report on Business

The Issuer continued to focus on its core business of developing and selling CBD products online in the United States and Europe. The Issuer has cancelled the acquisition of Franchise Cannabis Corp. ("FCC"), previously announced in January.

Effective April 16, 2021, the Issuer consolidated its issued and outstanding common shares ("Shares") at a ratio of ten (10) pre-consolidated Shares to one (1) post-consolidation Share (the "Consolidation").

Prior to the Consolidation, the Issuer had 389,274,701 Shares issued and outstanding. Following the Consolidation, the issued and outstanding Share capital of the Issuer is approximately 38,927,470. No fractional Shares were issued, and any fractions of a Share were rounded down to the nearest whole number of Shares. The exercise or conversion price and the number of Shares issuable under any of the Issuer's outstanding convertible securities have been proportionately adjusted upon Consolidation.

The new CUSIP is 885472209 and the new ISIN is CA8854722094.

On April 29, 2021, the Issuer announced that it is anticipating a delay in filing its audited financial statements for the year ended December 31, 2020, and the related management's discussion and analysis, and CEO and CFO certifications (collectively, the "Required Filings"), which are required to be filed on or before April 30, 2021.

In connection with the anticipated delay, the Issuer has applied to the applicable Canadian securities regulators requesting that a voluntary management cease trade order ("MCTO") be imposed to restrict trading in the Issuer's securities by insiders of the Issuer, as opposed to a general cease trade order, which would restrict all trading in the Issuer's securities. If granted, the MCTO will be in effect until the Required Filings are filed or until it is revoked or varied.

The majority of the Required Filings have been prepared, but the Issuer is unable to complete and file such materials as a result of delays associated with collection of the required data and documentation to complete the audit of the Issuer and its various subsidiaries. Restrictions on travel resulting from the ongoing COVID-19 pandemic have limited access to operations in the United States and Europe. The Issuer is continuing to work with its auditors to complete the required audit work, and the Issuer expects being in a position to file the Required Filings no later than May 14, 2021.
